1	Item – Introductions	Action

Sue stated she had used the film in her training throughout Somerset and surrounding areas. The feedback was positive and staff liked the animation. Sue would like to return in a year to feedback again. 4	Young Citizens Advice – Catherine Dougherty	
	<p>Catherine explained to the group about young citizen's advice. She explained that this was a free advice service for all young people. Catherine was keen to know what kind of things the service should be aware of and the types of advice and services that young people who are in or who have left care might need to know.</p>	<p>Lesley to add young citizen's advice to the website and share with Catherine the different things and services the group have previously identified as being important to young people in care.</p>

	<p>The group were reminded of their hopes and fears activity they completed last month. Fi read out some of the statements and all had to place themselves on a line between a happy face ☺ and a sad face ☹ depending on how strongly they agreed or disagreed with the statement. More help to young people – 13/18 agreed.

Look at individual needs before closing a case – 13/18 agreed.

More timely decision making – 11/18 agreed.

8	Helping Myself / Friend	
	<p>In 4 groups young people described what someone who needed help may look like. They then stated where they could go to get them help.</p>	<p>This will be used as part of a wider consultation in relation to young people accessing early help. The exercise will form part of a toolkit for participation workers and practitioners to use.</p> <p>Lesley to ensure that all services highlighted are included in the signpost section of the website.</p>
9	Storyboard for Health Assessments	
	<p>Young people are aware from Corporate Parenting Board that many young people refuse their health assessment. Some thought this was because young people did not know what to expect or the benefits. Young people decided it would be good to come with an idea for a small film to explain everything a young person needed to know about health assessments.</p>	<p>Angela is going to look into the possibilities of funding to help with this. Young people also discussed filming pictures to do this.</p>
